



## 12th European IDAHOT+ Forum Valletta, Malta

### **Charting Europe's Future** Advancing SOGIGESC Equality and Inclusion in a Transforming Europe

### 20<sup>th</sup> May, 2025

The central theme for the 12th European IDAHOT+ Forum, "Advancing SOGIGESC Equality and Inclusion in a Transforming Europe," reflects the dynamic and evolving landscape of human rights in the region. The Forum will explore strategies to enhance inclusivity, ensure equal treatment, and confront the complexities of discrimination in an increasingly diverse and interconnected Continent.

With an eye on the SOGIGESC equality agenda, the Forum seeks to challenge the forces of violence and discrimination that continue to threaten the safety and dignity of LGBTIQ+ individuals, striving for a Europe where equality is not just pursued but achieved. The programme will include plenary discussions and informal parallel sessions, each designed to contribute to this year's overarching theme.

#### 09:00 Opening Remarks

The Forum will commence with high-level addresses from key officials, policymakers, and representatives from international organisations. Speakers will set the stage by outlining the significance of the Forum's theme, "Advancing SOGIGESC Equality and Inclusion in a Transforming Europe," and reflecting on the state of LGBTIQ+ rights across the region. This session will underscore the need for continued collaboration, policy innovation, and community engagement to drive meaningful change.

#### 09:30 Presentations by International Non-Governmental Organisations

Leading international NGOs will provide an overview of recent developments in LGBTIQ+ rights across Europe, highlighting both progress and setbacks. These presentations will showcase key research findings, advocacy initiatives, and policy recommendations aimed at strengthening protections for LGBTIQ+ persons. The session will also offer a platform for discussing emerging challenges and identifying areas where civil society can work with governments and international bodies to advance equality and inclusion.

# 10:00 Advancing LGBTIQ+ Equality in Europe: Strategies, Challenges, and Future Directions

This session will explore the evolving legal and social landscape for LGBTIQ+ rights, assessing progress made and the challenges that persist. Experts and policymakers will discuss effective strategies for implementing national and regional action plans, ensuring the sustainability of equality measures, and addressing gaps in legal protections. The discussion will also examine the role of political will, grassroots

activism, and institutional support in securing long-term, meaningful change for LGBTIQ+ individuals across Europe.

## 11:15 Countering the Anti-Gender Movement: Protecting Equality and Inclusion in Europe

The rise of anti-gender and anti-LGBTIQ+ movements across Europe has posed significant threats to equality, human rights, and democratic values. This session will explore the narratives driving these movements, their impact on policy and public discourse, and strategies to counteract misinformation and backlash. Participants will discuss effective advocacy, legislative responses, and coalition-building efforts to safeguard progress and ensure a resilient human rights framework that upholds diversity and inclusion.

#### 14:00 From Recommendations to Action: Intergovernmental Organisations' Role in the Protection of the Rights of Intersex Persons

Intersex individuals continue to face legal, medical, and social challenges that require urgent attention from policymakers and institutions. This session will focus on how intergovernmental organisations are working to transform recommendations into concrete legal protections and policy measures. Experts will discuss the need for comprehensive legislation banning non-consensual medical interventions, improving access to justice, and fostering public awareness to dismantle harmful stereotypes and practices.

#### 15:30 Informal Parallel Sessions

#### *I. Championing Equality for LGBTIQ+ Persons in Sport*

Sport remains a space where LGBTIQ+ individuals often encounter discrimination, exclusion, and unequal opportunities. This session will explore the challenges faced by LGBTIQ+ athletes, particularly in relation to policies on participation, gender identity, and inclusion. Participants will discuss best practices for ensuring safe, fair, and equitable access to sports, including the role of sports federations, governments, and civil society in promoting inclusivity from grassroots to professional levels.

#### *II.* Ensuring Justice and Equality for LBTIQ+ Women

LBTIQ+ women often experience multiple and intersecting forms of discrimination, facing barriers to justice, representation, and social inclusion. This session will highlight key challenges related to legal protections, access to healthcare, workplace equality, and gender-based violence. The discussion will focus on how governments and institutions can strengthen legal frameworks and ensure that equality policies fully address the unique needs of LBTIQ+ women.

#### *III.* Intergovernmental Cooperation for Lasting LGBTIQ+ Equality

Achieving lasting progress in LGBTIQ+ equality requires strong collaboration between governments, civil society, and international organisations. This session will bring together policymakers, experts, and activists to explore strategies for strengthening legal protections, promoting social inclusion, and empowering LGBTIQ+ communities across Europe. Participants will discuss the role of intergovernmental cooperation in shaping effective policies, fostering accountability, and driving forward collective action. The session will highlight best practices, challenges, and opportunities for ensuring a coordinated and sustainable approach to equality.

#### 16:30 Key Takeaways: Synthesising Insights from the Informal Parallel Sessions

Following the parallel sessions, this discussion will consolidate key insights, identifying common challenges and cross-cutting recommendations. Speakers will highlight policy gaps, propose actionable solutions, and outline commitments for further collaboration. The session will also serve as a moment for aligning strategies across different focus areas and ensuring that all voices, particularly those from marginalised communities, are reflected in the Forum's outcomes.

#### 16:45 Final Reflections and Future Directions

As the Forum draws to a close, this session will provide an opportunity to reflect on the discussions held throughout the day and set the agenda for future action. Key stakeholders will share their perspectives on the most pressing issues in LGBTIQ+ equality and discuss the next steps for governments, civil society, and international bodies. The conversation will focus on maintaining momentum, addressing emerging challenges, and ensuring that commitments made during the Forum translate into tangible progress.

#### 17:15 Closing Remarks

The Forum will conclude with final remarks from key speakers, summarising the event's main outcomes and reinforcing commitments to advancing SOGIGESC equality. This session will serve as a call to action for continued collaboration, policy innovation, and advocacy efforts to ensure that LGBTIQ+ rights remain a priority across Europe.

The Forum will conclude with an Official Dinner, providing an opportunity for delegates to continue discussions in a more informal setting while strengthening networks and partnerships. The evening will also feature a symbolic handover ceremony, during which Malta, as the host of the 12th European IDAHOT+ Forum, will pass the Pride Flag to Denmark, marking their role as hosts for the 2026 edition.
